*Section 22-17 of the Election Code provides that within twenty-one (21) days after the close of such elections, the Election Authority shall canvass votes cast at the nonpartisan and consolidated elections for school district offices and public questions submitted to the voters within school district boundaries.

*The term of office of a person elected at a consolidated election held after January 1, 1998 shall begin upon the termination of his or her predecessor's term of office. Section 10-16 of the School Code, provides that the board shall organize and elect its officers and fix a time and place for regular board meetings at a meeting to be held within twenty-one (21) days of the consolidated election, which will be held on the first Tuesday of April in odd numbered years, subject to postponement to the first Tuesday following the last day of Passover if Passover falls on the first Tuesday of April.
